**AMENDMENT TO AMENDED AND RESTATED EIGHTH SUPPLEMENT  
TO THE MASTER DECLARATION OF COVENANTS, CONDITIONS AND  
RESTRICTIONS OF LAKEMOOR SUBDIVISION**

This Amendment to Amended and Restated Eighth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision (hereinafter referred to as the "Amendment to Amended and Restated Eighth Supplement") is made by the Lot Owners of the Lakemoor Subdivision and shall be effective upon it being recorded with the Ada County, Idaho Recorder's Office.

**RECITALS:**

A. In 2007, DMB Development, LLC (the "Declarant") owned and was subdividing and developing a certain parcel of property located north of Chinden Boulevard off of Eagle Road in Eagle, Idaho, to ultimately be known as the Lakemoor Subdivision (the "Lakemoor Subdivision");

B. The Lakemoor Subdivision was developed in ten (10) phases, which ten (10) phases are identified on the ten (10) recorded plats relating to the Lakemoor Subdivision and more particularly described as follows (collectively, the "Plats"):

- That certain plat for Lakemoor Subdivision No. 1 recorded with the Ada County, Idaho Recorder's Office on July 26, 2007, as Instrument No. 107105832 (the "First Plat");
- That certain plat for Lakemoor Subdivision No. 2 recorded with the Ada County, Idaho Recorder's Office on August 7, 2007, as Instrument No. 107111724 (the "Second Plat");

**AMENDMENT TO AMENDED AND RESTATED EIGHTH SUPPLEMENT TO THE  
MASTER DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS  
OF LAKEMOOR SUBDIVISION - 1**

- That certain plat for Lakemoor Subdivision No. 3 recorded with the Ada County, Idaho Recorder's Office on July 13, 2012, as Instrument No. 112069225 (the "Third Plat");
- That certain plat for Lakemoor Subdivision No. 4 recorded with the Ada County, Idaho Recorder's Office on December 26, 2013, as Instrument No. 113136881 (the "Fourth Plat");
- That certain plat for Lakemoor Subdivision No. 5 recorded with the Ada County, Idaho Recorder's Office on June 13, 2014, as Instrument No. 114046291 (the "Fifth Plat");
- That certain plat for Lakemoor Subdivision No. 6 recorded with the Ada County, Idaho Recorder's Office on October 12, 2017, as Instrument No. 2017-097209 (the "Sixth Plat");
- That certain plat for Lakemoor Subdivision No. 7 recorded with the Ada County, Idaho Recorder's Office on April 13, 2018, as Instrument No. 2018-033187 (the "Seventh Plat");
- That certain plat for Lakemoor Subdivision No. 8 recorded with the Ada County, Idaho Recorder's Office on November 15, 2019, as Instrument No. 2019-114490 (the "Eighth Plat");
- That certain plat for Lakemoor Subdivision No. 9 recorded with the Ada County, Idaho Recorder's Office on December 12, 2019, as Instrument No. 2019-124894 (the "Ninth Plat"); and
- That certain plat for Lakemoor Subdivision No. 10 recorded with the Ada County, Idaho Recorder's Office on October 15, 2020, as Instrument No. 2020-138301 (the "Tenth Plat").

C. On December 18, 2007, the Lakemoor Homeowner's Association, Inc., an Idaho non-profit corporation, was formed by filing Articles of Incorporation with the Idaho Secretary of State (the "Lakemoor HOA");

D. The undersigned are the president and secretary of the Lakemoor HOA, and certify and attest that this Fifth Amendment has been approved by the vote or written consent of an amount equal to or more than sixty-six and 2/3rds (66 2/3%) percent of the votes in the Lakemoor HOA as required by Section 3 of Article XVIII of the Declaration (defined below);

E. On or about February 15, 2007, DMB Development, LLC, as grantor, executed a certain Declaration of Covenants, Conditions, and Restrictions for Lakemoor in relation to the property described therein (the "Property"), which declaration was recorded with the Ada County, Idaho Recorder's Office on May 6, 2008, as instrument number 108057338 (the "Original Declaration");

F. Pursuant to Section 3 of Article XVIII of the Original Declaration, (i) the Declarant has the right to amend the Original Declaration, and any previous amendments thereto, and (ii) the Members of the Lakemoor HOA have the right to amend the Original Declaration, and any previous amendments thereto, by a sixty-six and 2/3rds (66 2/3) percent vote or approval;

G. On or about October 30, 2008, Declarant caused a First Amendment to Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 108009557 (the "First Amendment");

H. On or about December 31, 2013, Declarant caused a Second Amendment to Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 113138185 (the "Second Amendment");

I. On or about December 10, 2014, Declarant caused a Third Amendment to Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2014-099731 (the "Third Amendment");

J. On or about March 11, 2015, Declarant caused a Fourth Amendment to Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2015-019101 (the "Fourth Amendment");

K. On or about May 16, 2008, Declarant caused a First Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 108057339 (the "First Supplement");

L. On or about January 2, 2009, Declarant caused a First Supplement Amendment to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 109003182 (the "First Supplement Amendment");

M. On or about May 16, 2008, Declarant caused a Second Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 108057340 (the "Second Supplement");

N. On or about August 2, 2012, Declarant caused a Third Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 112077356 (the "Third Supplement");

O. On or about December 31, 2013, Declarant caused a Fourth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 113138184 (the "Fourth Supplement");

P. On or about January 21, 2014, Declarant caused a Fourth Supplement Amendment to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 114005000 (the "Fourth Supplement Amendment");

Q. On or about July 1, 2014, Declarant caused a Fifth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 114052209 (the "Fifth Supplement");

R. On or about March 19, 2020, Declarant caused a Sixth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2020-032323 (the "Sixth Supplement");

S. On or about May 3, 2018, Declarant caused a Seventh Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2018-040111 (the "Seventh Supplement");

T. On or about May 11, 2018, Declarant caused a Seventh Supplement Amendment to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2018-042742 (the "Seventh Supplement Amendment");

U. On or about March 19, 2020, Declarant caused an Eighth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded

with the Ada County, Idaho Recorder's Office as Instrument No. 2020-032380 (the "Eighth Supplement");

V. On or about April 20, 2020, Declarant caused an Eighth Supplement Amendment to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2020-045860 (the "Eighth Supplement Amendment");

W. On or about December 13, 2019, Declarant caused a Ninth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2019-125316 (the "Ninth Supplement");

X. On or about October 20, 2020, Declarant caused a Tenth Supplement to the Master Declaration of Covenants, Conditions and Restrictions of Lakemoor Subdivision to be recorded with the Ada County, Idaho Recorder's Office as Instrument No. 2020-14044 (the "Tenth Supplement");

Y. The Original Declaration, First Amendment, Second Amendment, Third Amendment, Fourth Amendment, First Supplement, First Supplement Amendment, Second Supplement, Third Supplement, Fourth Supplement, Fourth Supplement Amendment, Fifth Supplement, Sixth Supplement, Seventh Supplement, Seventh Supplement Amendment, Eighth Supplement, Eighth Supplement Amendment, Ninth Supplement, and Tenth Supplement are collectively defined and referred to herein as the "Declaration";

Z. Subject to the conditions set forth herein, the Lot Owners now desire to amend the Eighth Supplement Amendment to terminate the Association's obligation to pay for one-half of the electrical costs relating to the water feature and decorative bridge structure on the north side of Eagles Gate Drive; and

AA. Upon the recording hereof, the terms and provisions set forth in the Eighth Supplement Amendment shall be further amended by the terms of this Amendment to Amended and Restated Eighth Supplement.

**NOW, THEREFORE**, the Declaration shall be, and is hereby, amended as follows:

1. **Incorporation of Recitals.** The recitals set forth hereinabove are hereby incorporated herein as if set forth in full.

2. **Amendment.** Section E of ARTICLE XIV entitled “APPLICATION TO THE COMMERCIAL LOTS” as set forth in the Amended and Restated Eighth Supplement is hereby deleted in full and replaced with the following:

ARTICLE XIV: APPLICATION TO THE COMMERCIAL LOTS

E. A portion of Lot 1, Block 10 in the location depicted and/or described in Exhibit A attached hereto (the “Landscape Easement”) is subject to an easement for the benefit of the Master Association for the installation, placement, operation, maintenance, repair and replacement of landscaping, waterway and other decorative features, including a decorative bridge structure. The Master Association shall be responsible, at its sole expense, for the maintenance, repair and replacement of all landscaping improvements located in the Landscape Easement and for the operation, maintenance, repair and replacement of the water feature and bridge on the south side of Eagle's Gate Drive, including without limitation, all structures, appurtenances, mechanical and electrical equipment, pumps, pipes and any other improvements or equipment related thereto, and also including the cost of any electrical power supplied thereto. However, pursuant to a certain Cost Sharing Agreement effective as of October 30, 2023, entered into between the Association and GRH Lakemoor LLC, an Idaho limited liability company, PMAASP Stephens Lakemoor LLC, an Idaho limited liability company, JAD Holdings LLC, an Idaho limited liability company, and Lakemoor Land LLC, an Idaho limited liability company (collectively, “Hawkins”), recorded on November 2, 2023, with the Ada County, Idaho Recorder’s Office as Instrument No. 2023-062191, the Master Association shall not be responsible to pay for any of the cost of maintenance for, or the cost of electrical power supplied to, the water feature and decorative bridge structure on the north side of Eagles Gate Drive, and the Owner of that property on which the said water feature is located is responsible for the entire cost of electrical power to and cost of maintenance thereof.


3. **No Other Modifications to the Amended and Restated Eighth Supplement.** Except as amended herein, the Amended and Restated Eighth Supplement, as amended by this Amendment to Amended and Restated Eighth Supplement, shall remain in full force and effect with no other changes or modifications.


