2024 Assessment

The board completed the budget review for 2024 and voted to not raise the annual assessment so it will remain at \$550 plus the \$100 for the Harris Ranch Wildlife Mitigation Association fee. The 2024 invoice is included in this mailing. The 2024 budget will be reviewed at the annual meeting in February. Due to Legal Fees, much needed playground bark, long awaited rock replacement & fence post repairs on E Warm Springs we put less than we would have liked into the Reserve Fund in 2023.

Ornamental Yew Tree Community Alert

The Idaho Department of Fish and Game (IDFG) has issued warnings about the poisonous Ornamental Yew Tree. The entire plant, leaves and berries are poisonous and has caused death in humans, pets, wildlife, and cattle. Help keep our community safe and double check your yards! The Woven Development adjacent to East Valley and connected to S Brian St is moving forward and has cleared all the Boise City requirements. The Billboard has been removed and rumor has it they are going to demolish the buildings soon. They will rough grade the property and in the Spring start the finish grading, their underground work and street/curbs depending on the housing market.

East Warm Springs Treescape

We have been working with Barber Valley Neighborhood Association and Boise City to plant upwards of 40 trees along both sides of East Warm Springs. This will have aesthetic, sound mitigation and traffic calming benefits. This is in the conceptual stages and would be a Springtime installation. Look at the trees in front of East Jr, High and The Terraces to get the concept. This will also blend with the Woven streetscape.
